The following is an explanation of the options of protection offered by Enterprise Rent-A-Car:

Collision Damage Waiver (CDW) \$29.99/day or less

If Collision Damage Waiver (CDW) is accepted by the renter, barring any violation of the rental agreement's terms and conditions, the Company agrees to waive its rights to collect for damages or losses (all or part as specified in the terms and conditions of the rental agreement) sustained to the rental vehicle.

Supplemental Liability Protection (SLP) \$15.45/day or less

Supplemental Liability Protection (SLP) protects the renter and authorized driver(s) as defined in the rental agreement against claims made by third parties for Bodily Injury/Death and Property Damage caused by the use or operation of the rental vehicle. The coverage maximum is \$1 million. Enterprise is primary for liability if the renter chooses to purchase SLP. As with Collision Damage Waiver, Supplemental Liability Protection will not apply if there is any type of contract violation.

The renter and authorized driver(s) are covered while driving the rental vehicle within the United States and Canada provided the rental vehicle is rented and returned in the United States.
